CATCH Prep Charter High (CATCH) is committed to ensuring that the perspectives and input of students, school staff, families, and community members are included into the planning, implementation, and evaluation of how education is delivered at our school. In developing the ESSER III Expenditure Plan, CATCH consulted with the following community stakeholder groups, to the degree they are present or served by CATCH, in determining the prevention and mitigation strategies, strategies to address the academic impact of lost instructional time, and any other activities to be implemented with its ESSER III funding:

- CATCH Students in grades 9 through 12
- CATCH Families, including families that speak languages other than English
- CATCH School administrators and leaders, certificated and classified school staff, which includes the school’s principal, counselor, teachers and special education administrators and support staff; and

- Community organizations and advocacy groups/individuals representing civil rights and the interests of children with disabilities, English learners, homeless students, foster youth, migratory students, children who are incarcerated, and other underserved students at large (i.e., Urban League of Los Angeles, Therapy West, USC Professors, and non-profit organization leaders from Respect for Life International).

Starting in 2019 and continuing through 2021, CATCH used all communication outlets available (i.e., mail, telephone, email, school website, social media accounts, HelloWorks document subscription, SimpleTexting service subscription and Google Apps for Education Suite) to promote, engage in dialogue and collect information from stakeholders in identifying the unique needs of CATCH, especially as it related to the effects of the COVID-19 pandemic. Using such communication outlets, CATCH facilitated surveys tailored to each stakeholder group and engaged in interviews and focus group discussions during staff professional development sessions, student body forums, Back-to-School events for families and parent council and community member meetings. CATCH also provided a “Community Engagement Link” with a community survey on its school website homepage during the months of September and October of 2021 to provide additional opportunities for input from the public at large.

In addition to the feedback most recently collected to inform the ESSER III Expenditure Plan, previously collected input gathered via surveys during the development of existing school plans, like the LCAP and ELO Grant plan, were also reviewed and referenced in the development of this plan. Since the allowable uses of ESSER III monies allows CATCH to fund a broad range of activities in order to address the unique needs of its students, the input and insight was considered appropriate in determining strategies for continuous learning and addressing any opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

A description of how the development of the plan was influenced by community input.

The development of the ESSER III Expenditure Plans was influenced by, and developed in response to, stakeholder feedback and the input of the community at large. For example, CATCH students, families and staff members were asked to identify and prioritize areas of need with regards to safety, wellness and learning, and specific strategies/activities that they perceived essential to meet those needs. Furthermore, interviews and meeting sessions with community organization stakeholders and advocates provided insight as to their areas of concern with regards to programs and services being provided at their local neighborhood schools and what programs or services they would like to see continued or improved to advance student and staff learning and wellness for students at CATCH.

Overall, evidence from feedback indicated that CATCH’s schoolwide goals around student achievement and safe and healthy learning environments continue to be priorities among all stakeholder groups. Data and reflection on responses from all stakeholders suggested that continuous efforts need to be made to provide students with access to increased educational support focused on academics and social-emotional needs – especially as it related to the aftermath of the Coronavirus pandemic. Overwhelmingly, CATCH students and families continued to express the need for individualized academic support to meet skill development gaps, in addition to increased opportunities or staff to address social-emotional needs.

Furthermore, upon reviewing the input received, several themes emerged that determined the actions and expenditures noted in this plan, which included, implementing strategies to address staffing shortages, differentiating academic and social emotional supports by hiring additional certificated and classified staff, increasing mental health supports for students, and increasing opportunities for students to access individual

academic assistance to address specific learning needs and skill gaps. By focusing on the themes collected during the data and reflection process, actions were developed and are included in this plan.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and

 - Tracking student attendance and improving student engagement in distance education;
